Mission

Vision

The Big Dig grant application serves as a catalyst to our company and its employees who value working with non-profit organizations to enhance their community through the completion of a community service project that will:

- (1) help build a better tomorrow for the children and families of our area communities
- (2) encourage unity of community members of all ages to bridge the generation gaps
- (3) create a unique and lasting experience between our business, our employees, and our communities
- (4) educate the public on the value of the construction and mining industry and the benefit of having them be members of their community
- (5) bring out "the construction worker" in all the volunteers and benefactors by including them in the work

Community Service Projects will be completed / built in 2020-21. Due to the complexity and preparations for some of the projects selected, as well as our construction workload; the potential for project schedules to cross calendar years exists. Therefore, 2020 Big Dig Community Service Projects may carry into 2021.

What type of Community Service Projects can you apply for?

Community Service Project submittals should not be limited to gravel and asphalt type projects. The following are some examples of programs/events:

- community park improvements
- homeless shelter improvements/projects
- school playground
- school learning enhancements projects
- community center improvements
- food pantry improvements
- assistance/enhancements to children's programs

We encourage applicants to think "outside the box" when submitting their project.

Budget Parameters: It's ok to ask for the "sky" in hopes you get "the stars and/or the moon". See also page 6.

APPLICATION GUIDELINES:

<u>Non-profit</u> organizations from Adams, Columbia, Juneau, Marquette, Richland, and Sauk counties may complete the <u>Application Form 2020-2021</u>.

Please be specific in your grant application. Feel free to provide whatever format and supporting documentation your organization deems appropriate in filing a complete and persuasive application. *Our board reserves the privilege to request an interview in conjunction with your grant application to expound on your request.*

In addition, your organization must be willing to provide a three-year (side by side) of the charity's financials. *The financial stability of your organization will be a factor in the decision process.*

Your organization must be deemed a Charitable Organization by the State of Wisconsin, Department of Regulation and Licensing and the Internal Revenue Service. Current proof of supporting documentation will be required prior to project selection. Supporting documentation must include a copy of the letter from the Internal Revenue Service deeming your organization a 501(c)(3) as a public charity.

NOTE: A copy of the IRS Determination Letter stating that your organization would be exempt from Federal income tax under 501(c)(3) must be received prior to final grant approvals. Applications that do not have the required letter will not be considered for funding. (This is not the same letter as the State of Wisconsin Tax Exempt or EIN letter.)
